Moffitt follows parent's footsteps

Some children take over the family business, others follow in their father's footsteps, as the expression goes, but Oakland County Board of Commissioner David L. Moffitt has followed in his mother's footsteps with his election to the number two position on the board, vice chair.

Moffitt's mother, Lillian V. Moffitt, served on the Oakland County Board of Commissioners from 1973 to 1984, and from 1977 to 1984, she served as vice chair.

"It's an incredible feeling that I have watching my son take the position that I once held," Lillian V. Moffitt said.

Oakland County Clerk William G. Caddell noted after Moffitt's nomination that Moffitt was "the only commissioner in the history of the state, so far as I can tell, to have succeeded a parent as vice chairman of a board of commissioners."

From his early experiences working in grass roots Republican politics to watching his mother work late at night for an upcoming board meeting, Moffitt realizes that his role as vice chair will require a lot of hard work and dedication.

"The role of vice chair has never been clearly defined," Moffitt said, "although it has always been more than merely being able to step in for the chairman at any given moment."

"I hope to bring a new substance and specificity to the role of vice chairman," Moffitt continued.
